**CITY OF ASBURY**

**Mayor** - four year term: **Jim Adams** received 388 and was declared elected, Scott Rausch received 134 votes, Robert Blok received 38, and Pat Esch three votes.

**Two members of City Council** - four year terms: **Jaime Nedved** received 45 votes, **Andrew Kindle** 40 votes and were declared elected. Scott Rausch received 23 votes, Bob Blok had 10 votes, Ron Wartick 19 votes, Robert Peacock nine votes and 53 others received a scattering of 71 votes..
